We cooperate with professional forwarder Orient Star Transport Int'l Ltd, so we can ship the goods to worldwide buyers with best price and service.

Shipping for LCL order:

LCL means that the amount quantity of the order can't reach a full 20ft container.

Our prices are just EX-works price if your order can't reach a full container. So you should charge all the cost from our factory to your destination, including custom fee in China. If you have no shipping agent to deal with the shipment, Please tell me your detailed consignee address and the port of destination when you confirm the order, then we will offer you the shipping cost for your confirmation. and arrange the shipment when the goods is ready. Forwarder will ship the goods to your port of destination, You need to pick the goods and clear custom when the goods arrive. You can also find a local agent to deal with the case.

Shipping for FCL order:

FCL means that the amount quantity should reach a full 20ft container at least.

Our prices are FOB price for container order, you will just charge the cost from Chinese port to your destination. You'd better have your own shipping agent to arrange the shipment, then everything will be easy.

Of course, our forwarder can also arrange the shipment for you, but they can just ship the container to the port of destination, You need to pick it and clear custom when the container arrive in your port.

1. Choose a professional forwarder.

There are too many forwarders in China. According our experience, some forwarders are not responsible and professional. They don't clear the process of custom clearance and unable to deal with some affairs. They may make to process complex and pull all problems to seller or buyer. So find a good forwarder company and a professional operator is very important.

2. Choose a suitable shipping term.

Because of the interval between each cartons, a 20ft container can load 22 CBM, a 40ft container can load 56 CBM. We hope buyer can full use of whole container, so that the average transport fee is lower for each piece.
